During an inspection on 7 September, 2016 the following aspects of the organisation were considered.

Part A. About this Provider

A detailed description of this provider is given in the report following the inspection of the management systems on 20.06.16.

Part B. About this Visit

This was an arranged visit to inspect the practical application of the management of safety systems by observing an activity.

Part C. Activity Observation

The inspector joined a group of 20 participants on a climbing and abseiling session at the nearby crag known as Plump Hill.

The participants were a varied group from a private school that ‘specialises’ in offering targeted education for pupils with a variety of needs. Centre staff and visiting staff were engaged in attempting to encourage participation from all and were clearly experienced in identifying and coping with a variety of behaviours.

The crag was reached by a 20 minute walk from the centre which includes crossing a main road. From observation and discussion it was clear that the procedure for this had been carefully thought through.

Harness and helmet fitting and adjustment was carried out near the crag by Nathan whilst Mark rigged the anchors and ropes at the top. The climbs and abseil are located on a relatively easy angled slab. The rock is quite friable (a type of sandstone) and care needs to be taken to ensure climbers do not erode the holds with poor footwork. The anchors were arranged to facilitate lowering off rather than ‘topping out’ however quick access for staff to the top of the crag or as on the day the presence of a second competent member of staff at the top of the crag running the abseil means that participants can be safeguarded from above if required. The nature of the rock also means that care is always required to avoid issues with stonefall both by wearing helmets and by careful positioning of the participants.

The participants were divided into two groups of ten one group proceeding by a simple but longer path to a safe area at the top of the crag, and the others further subdivided into teams of 5 climbing and ‘peer’ belaying. On this occasion staff had chosen to use ‘grigri 2’ devices and lowering off was performed by the instructor. Other systems are permitted by the operating guidance at the discretion of the SPA qualified staff.

The abseil was rigged and supervised in a safe manner. One participant who would not have been able to complete an abseil alone was able to descend in ‘tandem’ with a visiting teacher.

The session appeared to confirm that the risk analysis and management systems claimed by the provider and/or seen in various documents were being implemented in practice.
